



## Online Consignment Sales Agreement SNL Sports, LLC

### Eligibility & Ownership

Customer must be at least eighteen (18) years of age, of sound mind, and acting in good faith. Customer represents lawful ownership of all inventory submitted and confirms that no items are stolen, counterfeit, or unlawfully obtained.

### Auction Structure & Minimums

Standard auctions run for approximately fifteen (15) seconds and typically begin at \$2.00. A minimum of three hundred (300) cards is required to run standard \$2.00 auctions. Submissions under 300 cards must consist of higher-value inventory, including slabbed, rare, numbered, or premium cards. All auctions are live, recorded, and available for review. Once an auction concludes, the sale is final and ownership transfers immediately to the buyer.

### Shipping & Refund Policy

SNL Sports, LLC will package and ship sold items within forty-eight (48) hours of auction, excluding weekends and holidays. Buyer payments may occasionally fail. Refunds are rare and issued solely at the discretion of SNL Sports, LLC.

### Fees & Payouts

Sales are conducted through Whatnot Auction House. Whatnot applies platform fees, typically around twelve percent (12%), plus a \$0.30 per transaction processing fee. SNL Sports, LLC earns thirty percent (30%) of the net sales price (final auction price), not net proceeds. All fees are deducted prior to customer payout.

### Illustrative Example

Example only: A \$2.00 card typically results in approximately \$0.84 paid to the customer after platform fees and SNL Sports' consignment fee. Actual results may vary due to fee changes, rounding, or platform policies.

### Acceptable Inventory

All cards must be sleeved. Accepted inventory includes numbered cards, variations, autographs, and rare or limited-production cards. Base cards of any kind are not accepted.

## Giveaways

SNL Sports, LLC may conduct free giveaways during live auctions to increase engagement. Estimated cost is approximately \$0.84 per giveaway, with up to twelve (12) giveaways per hour. Giveaways do not guarantee higher sale prices.

## High-Value Cards & Purchase Offers

SNL Sports, LLC may identify higher-value cards and set them aside for review prior to auction. SNL Sports may also make offers to purchase cards outright. Customers may accept or decline and choose to sell strictly online. No guarantee of market value or profitability is implied.

## Insurance, Care, Custody & Risk

SNL Sports, LLC takes reasonable care of inventory but does not insure consigned items. Care, custody, and control do not guarantee protection from loss, theft, or damage. Customers are responsible for their own insurance and assume all risk.

## Conduct & Respect Policy

Aggressive, abusive, or hostile behavior toward staff or others, whether in person or online, will result in immediate termination of services, return of inventory, and permanent refusal of future business. Choose kindness. Don't be a dick.
